PLEASE READ CAREFULLY AS THIS DOCUMENT INCLUDES A WAIVER OF RESPONSIBILITY

This Waiver of Responsibility and Assumption of Risk Agreement ("Agreement") is made by and between Global Cruises LLC ("Company"), including its cruise line partners, and the undersigned ("Participant"). By participating in tour activities operated by the Company and its partners, the Participant acknowledges and voluntarily accepts the risks associated with such activities, including bodily injury, sickness, death, or loss of personal property. These risks could stem from the physical conditions of the premises, natural disasters, animal encounters, weather conditions, water activities, food and beverage consumption, and the actions of other participants. The Participant confirms that she/he:

- ① **Medical Fitness:** Confirms that they are in good health and physically fit to participate in the tour activities, including any aquatic activities such as snorkeling, swimming, or boat excursions.
- ② **Water Activities:** Acknowledges the risks involved in aquatic activities, including drowning, encounters with animals, strong currents, watercraft collisions, and other hazards associated with water sports and boat tours. The Participant agrees to wear a life jacket or other safety equipment as required by the Company at all times.
- ③ **Minors:** Agrees that minors under their supervision are supervised at all times during the tour activities. The Participant accepts full responsibility for the safety and well-being of any minors in their care.
- ④ **Food and Beverage Consumption:** It is the Participant's responsibility to inform the Company of any allergies, or special dietary needs. The Participant assumes all risks associated with the consumption of food and beverages and agrees that the Company is not responsible for any allergic reactions, illness, or other adverse effects.
- ⑤ **Instruction and Safety Briefings:** Will adhere to all instructions provided by the Company or its representatives before participating in any tour activities. The Participant understands that failure to follow these instructions may result in increased risk of injury or death.
- ⑥ **Alcohol and Substance Use:** Agrees to participate in any activities soberly and responsibly.
- ⑦ **Duty to Report:** Agrees to report any accidents, injuries, or other incidents immediately to the Company's representatives.
- ⑧ **Personal Responsibility:** Accepts full responsibility for their personal safety and the safety of any minors under their care during the tour activities.
- ⑨ **Photo and video release:** Authorizes the recording and use of their image, likeness, voice, and performance in any media format for marketing, promotional, and public relations purposes by the Company and its partners, without further notice or compensation.
- ⑩ **Personal Liability:** Assume full responsibility for any risks, including theft, loss, injury, accidents, or death. I release the Company and its partners from all liability for damages resulting from abandoning the shore excursion and I confirm the information provided is accurate, and any omissions are my sole responsibility.

The Participant hereby releases, waives, discharges, and covenants not to sue the Company, its officers, directors, employees, agents, affiliates, representatives, subsidiaries, partners, including any and all Cruise Lines, and all other persons or entities acting on its behalf from any and all liability, claims, demands, losses, or damages caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations. **BY SIGNING, THE PARTICIPANT ACKNOWLEDGES THAT THEY FULLY UNDERSTAND ITS TERMS, RECOGNIZE THAT THEY ARE RELINQUISHING SUBSTANTIAL RIGHTS, INCLUDING THE RIGHT TO SUE, AND AFFIRM THAT THEY ACCEPT THESE CONDITIONS FREELY AND VOLUNTARILY.**
